4 pursuant to the attached Budget; and
5 WHEREAS, the Tohono O'odham Citizenship Campaign continues to work for the passage of the
6 Tohono O'odham Citizenship Act.
7 NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is authorized to expend the
8 \$10,000.00 gift in support of the Tohono O'odham Citizenship Campaign pursuant to
9 the attached budget.




