

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2003 Elderly Title III E, B, C-1, C-2 and Cash in Lieu of Commodities (CILC) Budget**  
**July 01, 2002 - June 30, 2003)**

**RESOLUTION NO. 02-260**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**  
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**  
4 **Title III of the Older American's Act of 1965 as amended, through the Administration**  
5 **of the Inter-Tribal Council of Arizona; and**

6 **WHEREAS, the services provided to elderly members has been beneficial and services continue**  
7 **to be necessary to provide nutritional and social support; and**

8 **WHEREAS, the Elderly Program has prepared budgets for FY 2003 Title III E, B, C-1, C-2 and Cash**  
9 **in Lieu of Commodities (CILC) funding to provide nutritional and social support**  
10 **services to eligible elderly members for period July 01, 2002 through June 30, 2003.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council:**

12 **1. That it hereby approves FY 2003 Title III-E \$25,305.00, Title III-B \$75,819.00, Title**  
13 **III C-1 \$69,768.00, Title III C-2 \$6,843.00 and Cash in Lieu of Commodities (CILC)**  
14 **\$5,378.00 funding to provide nutritional and social support services to eligible**  
15 **elderly members for period July 01, 2002 through June 30, 2003.**

16 **2. That it hereby approves the funds to be expended upon approval and acceptance**  
17 **of the grant award.**

18 **3. That 10% match is coming from the Tribal Budget.**

19 **4. The Tohono O'odham Nation Officials, to wit: the Chairman is hereby authorized**  
20 **to negotiate and execute the grant, provided however, that any amendments**  
21 **affecting the funding or funding levels of this contract shall be submitted for**  
22 **further prior approval by this Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
24 **of JUNE, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (I) of**  
26 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
