12		1. That it hereby approves FY 2003 Title III-E \$25,305.00, Title III-B \$75,819.00, Title
13		III C-1 \$69,768.00, Title III C-2 \$6,843.00 and Cash in Lieu of Commodities (CILC)
14		\$5,378.00 funding to provide nutritional and social support services to eligible
15		elderly members for period July 01, 2002 through June 30, 2003.
16		2. That it hereby approves the funds to be expended upon approval and acceptance
17		of the grant award.
18		3. That 10% match is coming from the Tribal Budget.
19		4. The Tohono O'odham Nation Officials, to wit: the Chairman is hereby authorized
20		to negotiate and execute the grant, provided however, that any amendments
21		affecting the funding or funding levels of this contract shall be submitted for
22		further prior approval by this Council.
