

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Submission and Negotiation of the Fiscal Year 2003 Annual Funding Agreement to the Indian Self-Determination Act Master Contract with the Bureau of Indian Affairs and Submission of Amendment No. 2 to the Master Contract extending the Term through to September 30, 2005)**

RESOLUTION NO. 02-261

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Bureau of Indian Affairs pursuant to the authority conferred to the Nation by the**
3 **Indian Self-Determination Act, as amended; and**

4 **WHEREAS, the Tohono O'odham Nation desires to continue operation of such programs,**
5 **functions, services and activities; and**

6 **WHEREAS, BIA Master Contract No. 1450CTH54T61071 is set to expire September 30, 2002 under**
7 **Modification No. 54 of September 29, 1999; and**

8 **WHEREAS, the Nation seeks to extend the Master Contract for an additional three-year term**
9 **through to September 30, 2005.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that the**
11 **Chairman is authorized to:**

- 12 **1. Submit the attached Fiscal Year 2003 Annual Funding Agreement to the Bureau**
13 **of Indian Affairs; and**
- 14 **2. Negotiate maximum funding and acceptance by the Bureau of the terms and**
15 **conditions contained therein; and**
- 16 **3. Submit the attached Amendment No. 2 to the Master Contract extending the term**
17 **of this Contract through to September 30, 2005.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
19 **of JUNE, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
21 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




