**RESOLUTION NO. 02-269**

2 **department directors be appointed by the Chairman of the Nation and be confirmed**  
3 **by the Tohono O'odham Legislative Council; and**

4 **WHEREAS, Ms. Kimberly Swanberg is qualified to assume the position of Treasurer with a degree**  
5 **in Business Administration concentrating in Accounting and experience working in**  
6 **Gaming Offices; and**


7 **WHEREAS, Ms. Kimberly Swanberg has accepted the appointment when offered by the Chairman**  
8 **of the Nation.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the**  
10 **appointment of Ms. Kimberly Swanberg is hereby confirmed.**

11 **BE IT FINALLY RESOLVED that Ms. Kimberly Swanberg shall serve at the pleasure of the Chairman**  
12 **of the Nation.**


13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
14 **of JUNE, 2002 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; 160.7**  
15 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**


