5 -0- NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1 of
6 Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation,
7 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
8 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
9 Act of June 18, 1934 (48 Stat. 984).


