

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Fiscal Year 2002 Department of Human Services Management of Health Budget  
Modification No. 1 for Indirect Cost Rate Adjustment and to Modify Budget Line Items)**

**RESOLUTION NO. 02-285**

1 **WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating**  
2 **the Management of Health Program under the P.L. 93-638 Master Health Contract**  
3 **with the Indian Health Service; and**

4 **WHEREAS, the Nation's Grants and Contracts Office notified the Management of Health Program**  
5 **that the Nation's indirect cost rate of 17.4% has been reduced to a fixed carry forward**  
6 **rate of 14.3% for FY 2002; and**

7 **WHEREAS, the Management of Health did submit and was approved by the Executive Branch, the**  
8 **modified budget with the current indirect cost rate of 14.3%; and**

9 **WHEREAS, the Management of Health is requesting to modify the existing budget line items to**  
10 **cover anticipated costs for the remainder of the fiscal year.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 12 **1. Does hereby approve and authorize expenditures in accordance with the attached**  
13 **budget modification #1 submitted by the Management of Health, Department of**  
14 **Human Services to change the indirect cost rate for 17.4% to 14.3% for fiscal year**  
15 **2002 and to modify existing line items in the Management of Health Budget for**  
16 **anticipated expenses for the remainder of the fiscal year.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
18 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
19 **-0-NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
20 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
