

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(To approve the FY 2002 TODHS Tohono O'odham Psychological Services (TOPS)  
638 Budget at \$803,151.82 to cover expenses effective October 1, 2001 through  
September 30, 2002)**

**RESOLUTION NO. 02-287**

1 **WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham**  
2 **Psychological Services program (TOPS) through a tribal subsidy, Indian Health**  
3 **Service 638 funding and third party revenues; and**

4 **WHEREAS, the FY 2001 carryover amount of \$87,489.00 plus an increase of \$14,685.00 from I.H.S.**  
5 **Modification #70, minus a decrease of \$69,975.00 from I.H.S. Modification #69 with a**  
6 **decrease of \$20,785.00 due to the reduction of indirect cost from 17.4% to 14.3% plus**  
7 **an increase in indirect cost of \$12,510.94 to cover the indirect cost for the carryover**  
8 **amount of \$87,489.00 with a total increase of \$100,485.46 was designated for the TOPS**  
9 **program making the final budget amount equal to \$803,151.82; and**

10 **WHEREAS, the TOPS program has transferred two (2) positions and a portion of the office**  
11 **supplies line item from the FY 02 TOPS Tribal budget to the TOPS 638 budget; and**

12 **WHEREAS, the TOPS program has prepared the FY 2002 638 budget to use funds to temporarily**  
13 **offset \$100,000.00 of the TOPS Tribal expenses incurred for the period of October 1,**  
14 **2001 through September 30, 2002.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
16 **approves:**

- 17 **1. The FY 2002 TODHS TOPS 638 budget at \$803,151.82 to cover expenses effective**  
18 **October 1, 2001 through September 30, 2002.**
- 19 **2. That the Indirect cost for this budget will be \$100,485.46.**
- 20 **3. That two (2) positions and a portion of the office supplies line item were**  
21 **transferred from the FY 02 TOPS Tribal budget to the TOPS 638 budget effective**  
22 **October 1, 2001 through September 30, 2002.**
- 23 **4. That any amount used to temporarily offset the Fiscal Year 2002 Tribal Base**  
24 **budgets will be returned when carry-over dollars are exhausted.**
- 25 **5. That the Tohono O'odham Nation's Official, to wit: the Chairman, Vice Chairman**  
26 **and any designated Officer are hereby authorized to negotiate and execute the**  
27 **proposal.**
