**RESOLUTION NO. 02-290**

1 **WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating**  
2 **the Division of Alcoholism and Substance Abuse Program Component under P.L. 93-**  
3 **638 Master Health Contract with the Public Health, Indian Health Services; and**

4 **WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance**  
5 **Abuse - Community Based Project of a decrease in the Indirect Cost from 17.4% to**  
6 **14.3% effective October 01, 2001; and**


7 **WHEREAS, the Division of Alcoholism & Substance Abuse Program - Community Based Project**  
8 **has submitted the attached budget modification #1 for review and approval by the**  
9 **Tohono O'odham Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
11 **approves:**

- 12           **1. The decrease of Indirect Cost of 17.4% to 14.3% effective October 01, 2001.**  
13           **2. The Tohono O'odham Nation's officials to wit; the Chairman is hereby authorized**  
14           **to negotiate and execute the contract.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
16 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
17 **-0-NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




