

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendments to the Gaming Authority Charter)

RESOLUTION NO. 02-294

1 **WHEREAS, by Resolution No. 93-311, the Nation adopted the Charter of the Tohono O'odham**
2 **Gaming Authority; and**

3 **WHEREAS, pursuant to Section 5(a) of the Gaming Authority Charter, the directors of the Gaming**
4 **Authority management board are appointed by the Chairman of the Nation and**
5 **approved by the Legislative Council for terms of three years each and are eligible for**
6 **reappointment upon expiration of their terms of office; and**

7 **WHEREAS, on March 7, 1995, by Resolution No. 95-098, the terms of office of many of the current**
8 **directors of the Gaming Authority management board were clarified, with terms**
9 **ending in 1995, 1996 and 1997; and**


10 **WHEREAS, it is in the interest of the Nation to again clarify the term of office of the directors of**
11 **the Gaming Authority management board.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 13 **1. The Gaming Authority Charter is hereby amended in the form attached hereto.**
- 14 **2. The Gaming Authority Charter shall be reprinted in its entirety showing a revision**
15 **date of July 2002.**
- 16 **3. The amendments to the Gaming Authority Charter approved hereby shall be**
17 **effective as of March 7, 1995.**
- 18 **4. The directors of the Gaming Authority management board authorized by**
19 **Resolution No. 95-098, are hereby deemed as having full authority under the**
20 **Gaming Authority Charter as directors from March 7, 1995 to the present.**
- 21 **5. The Chairman of the Nation is authorized and directed to take all reasonable and**
22 **necessary steps for implementation of this Resolution**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
24 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (c) of**
26 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
