

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Confirming the Appointment of Lucinda Hughes-Juan to the Economic  
Development Board)**

**RESOLUTION NO. 02-296**

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation adopted the Economic**  
2 **Development Plan of the Nation by means of Resolution No. 2000-013; and**

3 **WHEREAS, the adopted Economic Development Plan provided for establishment of an economic**  
4 **development authority; and**

5 **WHEREAS, the Economic Development Task Force developed a charter, plan of operation, and**  
6 **funding plan for the Economic Development Authority of the Tohono O'odham**  
7 **Nation; and**

8 **WHEREAS, these plans were adopted by the Legislative Council by means of Resolution 01-141**  
9 **and amended in Resolution 01-142; and**

10 **WHEREAS, the Charter for the Economic Development Authority of the Tohono O'odham Nation**  
11 **requires the Chairman to appoint seven members to the Economic Development**  
12 **Board of the Authority; and**

13 **WHEREAS, the Charter for the Economic Development Authority of the Tohono O'odham Nation**  
14 **requires that the Legislative Council of the Tohono O'odham Nation confirm the**  
15 **nominations to the Economic Development Board; and**

16 **WHEREAS, the Chairman of the Tohono O'odham Nation has submitted his nominations to the**  
17 **Economic Development Board for confirmation; and**

18 **WHEREAS, Lucinda Hughes-Juan has sufficient experience in business and economic**  
19 **development, and is a member of the Nation.**

20 **NOW, THEREFORE BE, IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**  
21 **confirms the following appointment to the Economic Development Board, subject to**  
22 **the terms of the Charter of the Economic Development Authority of the Tohono**  
23 **O'odham Nation:**

**Lucinda Hughes-Juan - 3 year Appointment to expire in June 30, 2005**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day**  
26 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (b) of**  
28 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
