10	WHEREAS,	the Tohono O'Odham Nation Fire Department has set aside monies in the FY 2002				
11		budget, line item 01-1095-810, for dispatching services; and				
12	WHEREAS,	the Agreement has been reviewed and approved by Executive Council to the				
13		Chairman and the relevant Oversight Committees (Executive/Domestic				
14		Affairs/Budget and Finance) of the Legislative Council.
