13		approves the application for \$250,000 from the USEPA for the General Assistance

16	of the Tohono O'odham Nation is hereby authorized to negotiate and execute the							
17	grant, provided however, that any amendments affecting the funding or funding

20	beginning on August 1, 2002 through July 31, 2006.
