

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Application and Acceptance of the Grant Award for the FY2003
Indian Environmental General Assistance Program (GAP) Grant)

RESOLUTION NO. 02-300

1 **WHEREAS, Article XVIII of the Constitution of the Tohono O'odham Nation sets out the Council's**
2 **continuing responsibility to assure for all members safe and healthful surroundings;**
3 **and**

4 **WHEREAS, the Tohono O'odham Nation has taken steps to protect its members and its**
5 **environment by applying for and receiving grant funds from the United States**
6 **Environmental Protection Agency (USEPA) under the Indian Environmental General**
7 **Assistance Program (GAP) and other programs; and**

8 **WHEREAS, the General Assistance Program is tasked with building the Nation's environmental**
9 **protection capacity and infrastructure; and**

10 **WHEREAS, the USEPA has reserved \$250,000 for the first year of a new 4-year cycle of GAP**
11 **funding that will extend from August 1, 2002 through July 31, 2006.**


12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the application for \$250,000 from the USEPA for the General Assistance**
14 **Program.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the Chairman**
16 **of the Tohono O'odham Nation is hereby authorized to negotiate and execute the**
17 **grant, provided however, that any amendments affecting the funding or funding**
18 **levels of the grant shall be submitted for further prior approval.**

19 **BE IT FURTHER RESOLVED that the GAP Program is authorized to expend funds from this grant**
20 **beginning on August 1, 2002 through July 31, 2006.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
22 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 1,834.1 FOR; -0- AGAINST;**
23 **583.4 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**
24 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


