

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2002 Water Resources Committee Budget Amendment No. 1)**

RESOLUTION NO. 02-301

1 **WHEREAS, the Water Resources Committee has been delegated the oversight responsibility for**
2 **water resources and activities on the Nation; and**

3 **WHEREAS, the water trust funds which are now appropriated on an annual basis to the Water**
4 **Resources Committee will ultimately be transferred to the Water Advisory Committee**
5 **upon adoption of the Water Advisory Committee's bylaws; and**

6 **WHEREAS, the Legislative Council did request that the Water Resources Committee develop and**
7 **submit an FY 2002 budget to the Council for consideration and adoption; and**

8 **WHEREAS, the Legislative Council did approve the Water Resources Committee's FY 2002 Budget**
9 **pursuant to Resolution No. 01-587; and**

10 **WHEREAS, the FY 2002 Water Resources Committee Budget requires amendments to:**

11 **(1) transfer \$5,000.00 from line item 750- Capital Equipment to line item 720-Office**
12 **Supplies;**

13 **(2) transfer \$10,000.00 from line item 660-Travel Transportation to line item 650-**
14 **Training and Registration; and**

15 **(3) include line item 650-Training/Registration, which was incorrectly omitted from**
16 **the Budget, but which was listed in the Budget Justification attached to**
17 **Resolution No. 01-587.**

18 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves the FY 2002 Water Resources Committee's Budget Amendment No. 1 as**
20 **reflected in the attached Budget Summary and Justification, which are hereby**
21 **incorporated by this reference.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
23 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 1,924.0 FOR; 332.8**
24 **AGAINST; 160.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (d)(3) and (i)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
26 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**


