

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2003 Distribution of Mining Royalties by Per Capita/Population  
Distribution (Amends Resolution No. 02-303))**

**RESOLUTION NO. 02-304**

1 **WHEREAS, during the July 10, 2002 General Session, the Budget and Finance Committee did**  
2 **present for consideration by the Legislative Council for the distribution of mining**  
3 **royalties, as follows:**

- 4 **1. equal distribution**
- 5 **2. per capita/population distribution; and**


6 **WHEREAS, the amounts of mining royalties available for distribution to the Nation's districts as**  
7 **of June 21, 2002, including interest accrued from May 30, 2000 through May 30, 2002**  
8 **per attached amounts were presented to the District Chairpersons at a meeting held**  
9 **on June 21, 2002; and**

10 **WHEREAS, the Legislative Council does hereby approve distribution of mining royalties by per**  
11 **capita/population distribution.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
13 **approves and authorizes the FY 2003 distribution of mining royalties by per**  
14 **capita/population distribution.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
16 **of JULY, 2002 at a meeting at which a quorum was present with a vote of 1,582.0 FOR; 755.15**  
17 **AGAINST; 80.35 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**


