

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2003 Distribution of Gaming Revenues by 50/50 Distribution**  
**(½ equal and ½ population))**

RESOLUTION NO. 02-306

1 WHEREAS, during the July 10, 2002 General Session, the Budget and Finance Committee did  
2 present three options on the distribution of gaming revenues for consideration by the  
3 Legislative Council: 1) equal distribution; 2) population distribution; and 3) 50/50  
4 distribution (½ equal and ½ population); and

5 WHEREAS, on June 21, 2002 the Budget and Finance committee made a presentation to the  
6 District Chairpersons regarding the current figures for each district under the  
7 gaming distribution; and

8 WHEREAS, the Legislative Council does hereby approve distribution of gaming revenues by 50/50  
9 Distribution (½ equal and ½ population).

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
11 approves and authorizes the FY 2003 distribution of gaming revenues by 50/50  
12 Distribution (½ equal and ½ population).

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day  
14 of JULY, 2002 at a meeting at which a quorum was present with a vote of 1,883.45 FOR; 534.05  
15 AGAINST; -0-NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section  
16 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
17 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
19 Stat. 984).




