

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Modification One to the Economic Development Department Initiative Budget)**

RESOLUTION NO. 02-307

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation approved the FY 2002 budget**
2 **for the Economic Development Department and other programs funded by the**
3 **Initiative Administrative cost Appropriations; and**
4 **WHEREAS, the Economic Development Department wishes to modify its FY 2002 budget to**
5 **reprogram funds without changing the total amount of its budget; and**
6 **WHEREAS, the modification includes addition of the Utilities line item, to pay for installation of**
7 **utilities at the department's facility in San Xavier; and**
8 **WHEREAS, the Economic Development Department has prepared a budget modification to**
9 **accomplish these changes, and**
10 **WHEREAS, the modification has been reviewed and approved by the Executive Office, Commerce**
11 **Committee and Budget and Finance Committee.**
12 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
13 **approves Modification One of the FY 2002 Budget for the Economic Development**
14 **Department as shown in the attached document.**


15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**

17 **80.35 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**
18 **(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**
