2 O'odham Nation, and that their application is approved, as herein above indicated.  
3 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono  
4 O'odham Nation reduce this final determination in writing regarding each of the  
5 foregoing applications for enrollment in accordance with Section 1(a) of Article  
6 XIII of the Enrollment Ordinance; give notice of this Council's determination in  
7 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place  
8 the names of each applicant upon the membership roll of the Tohono O'odham  
9 Nation in accordance with Sections 2 and 3 of Article X of the Enrollment  
10 Ordinance.

11 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 05<sup>th</sup> Day  
12 of AUGUST, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
13 AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by  
14 Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham  
15 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
16 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
17 of the Act of June 18, 1934 (48 Stat. 984).
