10	firms – Williams & Works, P.A. and Janov & Cooney, L.L.P.; and
11	WHEREAS, the Attorney General has proposed Amendment No. 2 to the Attorney Contract which,
12	effective April 29, 2002, would substitute the law firm of Williams & Works, P.A. for
13	Williams, Janov & Cooney, P.C. as the Attorneys designated in the Attorney Contract;

15	WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of
16	Amendment No. 2 to the Attorney Contract.

19	Attorney Contract, in the form attached hereto.
