RESOLUTION NO. 02-349

1 WHEREAS, the Sif Oidak District Council approved their Fiscal Year 2003 Budget at a meeting
2 held on July 31, 2002; and

3 WHEREAS, on August 08, 2002, Sif Oidak District presented their Fiscal year 2003 budget request
4 in the amount of \$1,379,822.00 to the Tohono O'odham Legislative Council for their
5 approval; and


6 WHEREAS, the Sif Oidak District does have sufficient funds in their own account to implement
7 the budget amount requested.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports
9 and approves the FY 2003 Sif-Oidak budget in the amount of \$1,379,822.00.

10 BE IT FINALLY RESOLVED that the District be authorized to expend their FY 2003 budget from
11 August 01, 2002 to July 31, 2003.


12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08th Day
13 of AUGUST, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
14 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).
