

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirming the Appointment of Juan Lopez to the Economic Development Board)**

RESOLUTION NO. 02-352

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation adopted the Economic**
2 **Development Plan of the Nation by means of Resolution 2000-13; and**

3 **WHEREAS, the adopted Economic Development Plan provided for establishment of an economic**
4 **development authority; and**

5 **WHEREAS, the Economic Development Task Force developed a charter, plan of operation, and**
6 **funding plan for the Economic Development Authority of the Tohono O'odham**
7 **Nation; and**

8 **WHEREAS, these plans were adopted by the Legislative Council by means of Resolution 01-141**
9 **and amended in Resolution 01-142; and**

10 **WHEREAS, the Charter for the Economic Development Authority of the Tohono O'odham Nation**
11 **requires the Chairman to appoint seven members to the Economic Development**
12 **Board of the Authority; and**

13 **WHEREAS, the Charter for the Economic Development Authority of the Tohono O'odham Nation**
14 **requires that the Legislative Council of the Tohono O'odham Nation confirm the**
15 **nominations to the Economic Development Board; and**

16 **WHEREAS, the Chairman of the Tohono O'odham Nation has submitted his nominations for the**
17 **Economic Development Board to be confirmed; and**

18 **WHEREAS, Juan Lopez has sufficient experience in business and economic development, and is**
19 **a member of the Nation.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono**
21 **O'odham Nation confirms the following appointment to the Economic Development**
22 **Board, subject to the terms of the Charter of the Economic Development Authority of**
23 **the Tohono O'odham Nation.**

24 **BE IT FINALLY RESOLVED that Juan Lopez fill the unexpired term of Ruben Norris set to expire**
25 **April 30, 2003**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08th. Day**
27 **of AUGUST, 2002 at a meeting at which a quorum was present with a vote of 2,264.9 FOR; 152.6**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
