14 **named applicant is eligible for enrollment as a member of the Tohono O'odham**
15 **Nation under Section 1(a) or (b) of Article II of the Constitution of the Tohono**
16 **O'odham Nation, and that their application is approved, as herein above indicated.**

17 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono
18 **O'odham Nation reduce this final determination in writing regarding each of the**
19 **foregoing applications for enrollment in accordance with Section 1(a) of Article**
20 **XIII of the Enrollment Ordinance; give notice of this Council's determination in**
21 **accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place**
22 **the names of each applicant upon the membership roll of the Tohono O'odham**
23 **Nation in accordance with Sections 2 and 3 of Article X of the Enrollment**
24 **Ordinance.**

25 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09th Day**
26 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**
29 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
31 **of the Act of June 18, 1934 (48 Stat. 984).**
