2 **present; and**


3 **WHEREAS, the FY 2003 district budget was presented for review and referred to the communities**

5 **WHEREAS, Chukut Kuk District does have sufficient funds to cover the proposed budget amount.**

6 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves**
7 **the Chukut Kuk District Budget for FY 2003 in the amount of \$996,631.30.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH, Day**
9 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
11 **Section 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
12 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat. 984).**


