8	WHEREAS, the Elderly Program Title III-B budget is hereby amended by \$12,371.00 to reflect the
9	increased funding amount; and
10	WHEREAS, the Elderly Program Title C-1 budget is hereby amended by \$3,593.00 to reflect the
11	decreased funding amount; and
12	WHEREAS, the Elderly Program Title III C-2 budget is hereby amended by \$33,175.00 to reflect the
13	increased funding amount.
14	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
15	approves:
16	1. a) The Title III-B Budget Amendment #1 to increase funds from \$75,819.00 to
17	\$88,190.00, an increase of \$12,371.00 to reflect the funding increase.
18	b) The Title III C-1 Budget Amendment #1 to decrease funds from \$69,768.00 to
19	\$66,175.00, a decrease by \$3,593.00 to reflect the funding decrease.
20	c) The Title III C-2 Budget Amendment #1 to increase funds from \$6,843.00 to
21	\$40,018.00, an increase of \$33,175.00 to reflect the funding increase.
22	2. The expenditure of budget amendment #1 upon approval of grant award.
23	3. The Tohono O'odham Nation officials, to wit: The Chairman is hereby authorized
24	to negotiate and execute the grant, provided however, that any amendments
25	affecting the funding or funding levels of this grant shall be submitted for further
26	prior approval by this Council.
