

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of FY 2003 Title VI, Part C Native American Family Caregiver Program  
Budget Amendment #1)**

**RESOLUTION NO. 02-375**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**  
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been made possible in**  
4 **part by Title VI of the Older American's Act of 1978 as amended and U.S. Department**  
5 **of Agriculture, Nutrition Services Incentive Program; and**

6 **WHEREAS, Title VI, Part C Native American Family Caregiver Support Program received a total**  
7 **Grant Award of \$42,810, an increase of \$7,810.00 and hereby amends the original**  
8 **Budget to include the increase reflected in the budget attached; and**


9 **WHEREAS, the budget amendment #1/modification #1 also reflects Indirect Cost adjustments**  
10 **from 17.4% to 14.3% and utilizing savings of the adjustment for other line items.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **approves:**

- 13 **1. The FY 2003 Title VI, Part C Native American Family Caregiver Support Program**  
14 **Budget Amendment #1/Modification #1 to increase by \$7,810.00 so the budget can**  
15 **reflect the total Grant Award of \$42,810.00.**
- 16 **2. The Budget Amendment #1/Modification #1 Indirect Cost adjustments from 17.4%**  
17 **to 14.3% and to utilize the savings of the adjustment for other line items.**
- 18 **3. The Tohono O'odham Nation officials, to wit: The Chairman or designated official**  
19 **are hereby authorized to negotiate and execute the grant, provided however, that**  
20 **any amendments affecting the funding or funding levels of this contract shall be**  
21 **submitted for further prior approval by this Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
23 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,232.8 FOR; 184.7**  
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**


