RESOLUTION NO. 02-376

1 **WHEREAS, the Tohono O'odham Nation approved FY 2002 BIA 638 Social Services Budget on**
2 **December 28, 2001, Resolution Number 01-634 in the amount of \$2,616,896.73; and**

3 **WHEREAS, the Tohono O'odham Department of Human Services is presently operating the**
4 **Divisions of Family Assistance, Child Welfare and Senior Services through an approved**
5 **FY2002 BIA 638 budget; and**

6 **WHEREAS, a budget amendment number one has been submitted and an additional \$23,246.00**
7 **has been allocated for administrative funds to be utilized in current line items and**
8 **creation of one additional line item; and**

9 **WHEREAS, the Indirect Cost amount has changed from 17.4% to 14.3% and is hereby reflected**
10 **within budget amendment number one; and**

11 **WHEREAS, any amendments affecting the funding or funding levels of the contract shall be**
12 **submitted for review and approval by the Tohono O'odham Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 14 **1. It hereby approves and authorizes FY2002 BIA 638 budget amendment number one**
15 **for the Department of Human Services, Divisions of Family Assistance, Child**
16 **Welfare and Senior Services in the total amount of \$2,618,635.47; and**
- 17 **2. It also authorizes the Indirect Cost change from 17.4% to 14.3% to budget**
18 **amendment number one; and**
- 19 **3. Approves and authorizes expenditures in accordance with the attached budget;**
20 **and**
- 21 **4. The Tohono O'odham Nation's Official to wit: The Chairman is hereby authorized**
22 **to negotiate and execute the contract.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
25 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 1,546.4 FOR; -0-**
26 **AGAINST; 871.1 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
