3	WHEREAS, the Tohono O'odham Department of Human Services is presently operating the
4	Divisions of Family Assistance, Child Welfare and Senior Services through an approved
5	FY2002 BIA 638 budget; and
6	WHEREAS, a budget amendment number one has been submitted and an additional \$23,246.00
7	has been allocated for administrative funds to be utilized in current line items and
8	creation of one additional line item; and
9	WHEREAS, the Indirect Cost amount has changed from 17.4% to 14.3% and is hereby reflected
10	within budget amendment number one; and
11	WHEREAS, any amendments affecting the funding or funding levels of the contract shall be
12	submitted for review and approval by the Tohono O'odham Legislative Council.
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:
14	1. It hereby approves and authorizes FY2002 BIA 638 budget amendment number one
15	for the Department of Human Services, Divisions of Family Assistance, Child
16	Welfare and Senior Services in the total amount of \$2,618,635.47; and
17	2. It also authorizes the Indirect Cost change from 17.4% to 14.3% to budget
18	amendment number one; and
19	<ol><li>Approves and authorizes expenditures in accordance with the attached budget;</li></ol>

21	4. The Tohono O'odham Nation's Official to wit: The Chairman is hereby authorized
22	to negotiate and execute the contract.
