RESOLUTION NO. 02-383

1 **WHEREAS, the Gu-Vo District Governing Council called a Special meeting on Friday, 06**
2 **September 2002, to review and finalize the District Fiscal Year 2002/2003 Budget; and**

3 **WHEREAS, the Gu-Vo District Governing Council did realize that it will take more than one**
4 **meeting to finalize the budget; and**

5 **WHEREAS, the Gu-Vo District Governing Council has determined that it is in the best interest of**
6 **the District to request a continuation of FY2001/2002 District budget for a period of**
7 **one (1) month; and**

8 **WHEREAS, the Gu-Vo District does have sufficient funds available to cover the continuation of**
9 **FY2001/2002.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the continuation of the Gu-Vo District FY2001/2002 Budget for one (1) month pending**
12 **approval of the FY2002/2003 District Budget.**

13 **BE IT FURTHER RESOLVED that the Gu-Vo District does have sufficient funds available to cover the**
14 **continuation of FY2001/2002 Budget.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH, Day**
16 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and 144.5 [07] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**


