


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorization to Continue San Xavier District Government Operations Pending  
Approval of its FY 2002/2003 Budget)**

**RESOLUTION NO. 02-384**

1 **WHEREAS, the San Xavier District is unable to forward its FY 2002/2003 approved budget to the**  
2 **Tohono O'odham Legislative Council (TOLC) before the end of the fiscal year; and**  
3 **WHEREAS, it is in the best interest of the San Xavier District (District) to continue its fiscal year**  
4 **operation pending the review and approval of its FY 2002/2003 budget by TOLC; and**  
5 **WHEREAS, the District has sufficient funds in its treasury to cover all expenditures during this**  
6 **interim period.**  
7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
8 **the San Xavier District to continue to expend funds for its regular operation at the**  
9 **FY2001/2002 level unit until its FY 2002/2003 budget has been reviewed and**  
10 **sanctioned by the Tohono O'odham Legislative Council.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH, Day**  
12 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-**  
13 **AGAINST; -0- NOT VOTING; and 144.5 [06] ABSENT, pursuant to the powers vested in the Council by**  
14 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
15 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
17 **18, 1934 (48 Stat. 984).**
