

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of Pisinemo District FY 2003 Budget)**

RESOLUTION NO. 02-387

1 WHEREAS, at a regularly scheduled session of the Legislative Council, Pisinemo District did  
2 present the District Operating Budget for Fiscal Year 2003 in the amount of  
3 \$531,443.00; and

4 WHEREAS, the Tohono O'odham Legislative Council did review the proposal of Pisinemo District;  
5 and

6 WHEREAS, the Tohono O'odham Legislative Council did determine that there was sufficient funds  
7 with the Nation's Distribution of \$401,282.90 and \$7,382.38 from Mining Royalties  
8 distribution and \$122,777.72 from the Pisinemo District's Bank Account to support  
9 this proposal; and

10 WHEREAS, Pisinemo District Council did approve their FY 2003 Budget through Pisinemo District  
11 Council Resolution 2002-23 dated September 3, 2002.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve  
13 the FY 2003 Operating Budget of the Pisinemo District in the amount of \$531,443.00.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day  
15 of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; 0-  
16 AGAINST; 0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
17 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
18 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
20 18, 1934 (48 Stat. 984).
