

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Support for A Second Continuation Authorization for Home Renovation Supplement Budget)

RESOLUTION NO. 02-389

1 WHEREAS, at a regularly scheduled session of the Legislative Council, Pisinemo District did
2 present a proposal for a second continuation for another six months of the Home
3 Renovation Budget under the \$500,000 Supplement monies; and


4 WHEREAS, the proposal is requesting a second continuation on the \$500,000 supplement to fund
5 the Home Renovation Project utilizing projected savings the District will have by the
6 end of September 30, 2002; and

7 WHEREAS, the total amount of funding required for the Home Renovation Project to be extended
8 for another six months ending on March 31, 2002 is \$180,222.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council finds there is
10 sufficient monies available to continue the Pisinemo District's Home Renovation
11 Project for another six months in the amount of \$180,222 for a salaries, fringe
12 benefits, and an operating budget.

13 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day
14 of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
15 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
16 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
17 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
19 18, 1934 (48 Stat. 984).
