

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval for Request for Extension of Time and Authorization to Expend Funds
for FY 2003 on Grant Agreement No. 01-NA-32-00200 for Schuk Toak New
Farm Development)

RESOLUTION NO. 02-395

1 **WHEREAS, The Tohono O'odham Nation ("Nation") did previously adopt under Resolution No. 01-**
2 **318, a Grant Agreement ("Agreement") No. 01-NA-32-00200 with the Bureau of**
3 **Reclamation for an amount of \$335,027.00 to finance the purchase of major**
4 **equipment needed to maintain and operate the water distribution system at the**
5 **Schuk Toak New Farm Development; and**

6 **WHEREAS, the current expiration date of the Grant Agreement No. 01-NA-32-00200 is September**
7 **30, 2002; and**

8 **WHEREAS, the Water Projects Office has already purchased the heavy equipment including the**
9 **motor grader, backhoe loader, spider sprayer, and two (2) vehicles; and**

10 **WHEREAS, the Water Projects Office still has equipment that needs to be purchased once the**
11 **farm maintenance facility is completed because of installation and storage purposes**
12 **and the remaining equipment can be purchased using carry-over funds from the**
13 **existing Agreement; and**

14 **WHEREAS, the Water Projects Office is recommending an extension of the Agreement for an**
15 **additional one-year until September 30, 2003; and**

16 **WHEREAS, the Water Projects Office is submitting a budget to expend funds for the remaining**
17 **equipment needed for Schuk Toak Farm in the amount of \$52,930.00**

18 **WHEREAS, The Water Projects Office has presented this request and budget to the appropriate**
19 **oversight committees and is recommended for approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
21 **approves an extension of Bureau of Reclamation Grant Agreement No. 01-NA-32-**
22 **00200 for an additional one-year until September 30, 2003, and grants authorization**
23 **to the Water Projects Office to expend funds of \$52,930.00 to purchase the remaining**
24 **equipment as attached and incorporated by this reference.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes and**
26 **directs the Chairman of the Nation to negotiate and execute an extension to the Grant**
27 **Agreement No. 01-NA-32-00200.**




