WHEREAS,	the Tohono O'Odham Nation entered into a Public Law 93-638 Grant Agreement with
	the Bureau of Reclamation, Agreement No. 6-FG-32-00100, for the construction of a
	distribution system for delivery of Central Arizona Project Water to the Schuk Toak
	District of the Tohono O'Odham Nation in December 1995; and
WHEREAS,	the current expiration date of the Grant Agreement 6-FG-32-00100 is September 30,
	2002, and the construction and the management work now scheduled cannot be
	completed within the time remaining; and
WHEREAS,	the Water Projects Office has assessed the work in progress and funds remaining, and
	has recommended to the Legislative Council that the Grant Agreement be extended
	for an additional year so as to expire on September 30, 2003, and include the budget
	for FY 2003 as attached and incorporated by this reference; and
WHEREAS,	the work remaining under the Grant Agreement for construction and close-out
	activities can be accomplished, under the assumption that funding and processing
	activities are completed in a timely manner throughout the Fiscal Year 2003; and
WHEREAS,	the Water Projects Office has presented this matter to the appropriate committees
	and the committees wish to bring it before the Legislative Council.
NOW, THER	EFORE, BEIT RESOLVED that the Tohono O'Odham Legislative Council hereby proposes
	a one-year extension of Grant Agreement 6-FG-32-00100 with The Bureau of
	Reclamation from  October  1,2002  through  September  30,2003, in  order  to  complete
	activities related to construction and close-out.
BE IT FURT	HER RESOLVED that the FY 2003 budget in the amount of \$740,875.03 for the one-year
	extension of Grant Agreement 6-FG-32-00100 as attached hereto and incorporated
	by this reference, and that the Water Projects Office is authorized to expend funds in
	accordance with this budget.
BE IT FINAI	LY RESOLVED that the Chairman of the Nation is hereby authorized and directed to
	execute a one-year extension of BOR Grant Agreement 6-FG-32-00100.
