5 **and approves the Continuing Resolution for the Schuk Toak District FY - 2002 Budget.**


6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**

8 **AGAINST; -0- NOT VOTING; and 160.7 [05] ABSENT, pursuant to the powers vested in the Council by**
9 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
10 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**


