9 10	Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12	18, 1934 (48 Stat. 984).
