

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 95-015, "Approval of the Nursing Home Project Set-Aside
Budget of 33 Equal Monthly Distributions [\$450,000.00] for Fiscal Years 1994/1995,
1995/1996, 1996/1997 in the Total Amount of \$13,500,000.00" as amended by
Resolution No. 95-016, "Amending Resolution No. 95-015")

RESOLUTION NO. 02-400

1 **WHEREAS, pursuant to Resolution No. 95-015, as amended by Resolution No. 95-016, the Tohono**
2 **O'odham Legislative Council appropriated \$14,850,000 from the Desert Diamond**
3 **Savings Account, Account No. 68-01-101-1067514 (the "Appropriated Amount"), to**
4 **fund the Nursing Home Project (the "Project"); and**

5 **WHEREAS, the Appropriated Amount was deposited in a segregated investment account, Account**
6 **No. 68-01-101-8453880 (the "Investment Account"), and available to pay the**
7 **designated costs; and**

8 **WHEREAS, interest and other earnings in the Investment Account were not dedicated to payment**
9 **of such costs.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

11 **1. The Tohono O'odham Legislative Council hereby amends Resolution 95-015, as**
12 **amended by Resolution 95-016, as follows:**

13 **(a) All past and future interest and other earnings on the Principal Amount (as**
14 **defined below) in the Investment Account shall be retained by the Tohono**
15 **O'odham Nation and available to fund governmental operations and projects of**
16 **the Nation.**

17 **(b) Such accrued interest and other earnings shall be transferred to the General**
18 **Fund (Account No. 68-01-101-1067508) on a quarterly basis.**

19 **2. For purposes of this Resolution, the term "Principal Amount" means the**
20 **Appropriated Amount less any withdrawal of funds from the Appropriated**
21 **Amount for expenditure on the Project pursuant to an approved budget or other**
22 **authority granted by the Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
25 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,250.2 FOR; 167.3**
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
