

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 01-110, "Appropriation of funds for the year one**  
**operations of the Archie Hendricks, Sr., Skilled Nursing Care Center, for the**  
**construction of twenty-nine (29) staff housing units and for the addition of**  
**funds to cover expected deficit projection of fiscal year 2001 budget" as**  
**amended by Resolution No. 01-111, "Amending Resolution No. 01-110")**

**RESOLUTION NO. 02-401**

1 **WHEREAS, pursuant to Resolution No. 01-110, as amended by Resolution No. 01-111, the Tohono**  
2 **O'odham Legislative Council appropriated \$10,374,562.29 from the Desert Diamond**  
3 **Savings Account, Account No. 68-01-101-1067514 (the "Appropriated Amount"), for**  
4 **one year of operations, elimination of a deficit and construction of staff housing**  
5 **related to the Nursing Home Project (the "Project"); and**

6 **WHEREAS, the Appropriated Amount was deposited in a segregated investment account, Account**  
7 **No. 68-01-101-0369553 (the "Investment Account"), and available to pay the**  
8 **designated costs; and**

9 **WHEREAS, interest and other earnings in the Investment Account were not dedicated to payment**  
10 **of such costs.**

11 **NOW, THEREFORE, BE IT RESOLVED THAT:**

12 **1. The Tohono O'odham Legislative Council hereby amends Resolution No. 01-110,**  
13 **as amended by Resolution No. 01-111, as follows:**

14 **(a) All past and future interest and other earnings on the Principal Amount (as**  
15 **defined below) in the Investment Account shall be retained by the Tohono**  
16 **O'odham Nation and available to fund governmental operations and projects of**  
17 **the Nation.**

18 **(b) Such accrued interest and other earnings shall be transferred to the General**  
19 **Fund (Account No. 68-01-101-1067508) on a quarterly basis.**

20 **2. For purposes of this Resolution, the term "Principal Amount" means the**  
21 **Appropriated Amount less any withdrawal of funds from the Appropriated**  
22 **Amount for expenditure on the Project pursuant to an approved budget or other**  
23 **authority granted by the Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
25 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,250.2 FOR; 167.3**  
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
