

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 97-478, "Establishing Set-Aside Accounts at Bank of
America for Initiative Measures")

RESOLUTION NO. 02-402

1 **WHEREAS, pursuant to Resolution No. 97-478, the Tohono O'odham Legislative Council**
2 **appropriated \$30,000,000 from the Desert Diamond Savings Account, Account No. 68-**
3 **01-101-1067514 (the "Appropriated Amount"), for the construction and operation of**
4 **five Youth Centers (the "Project"); and**

5 **WHEREAS, the Appropriated Amount was deposited in segregated investment accounts, Account**
6 **Nos. 68-01-101-1067521 and 68-01-101-0376848 (the "Investment Account"), and**
7 **available to pay the designated costs; and**

8 **WHEREAS, interest and other earnings in the Investment Account were not dedicated to payment**
9 **of such costs.**

10 **NOW, THEREFORE, BE IT RESOLVED THAT:**

11 **1. The Tohono O'odham Legislative Council hereby amends Resolution 97-478 as**
12 **follows:**

13 **(a) All past and future interest and other earnings on the Principal Amount (as**
14 **defined below) in the Investment Account shall be retained by the Tohono**
15 **O'odham Nation and available to fund governmental operations and projects of**
16 **the Nation.**

17 **(b) Such accrued interest and other earnings shall be transferred to the General**
18 **Fund (Account No. 68-01-101-1067508) on a quarterly basis.**

19 **2. For purposes of this Resolution, the term "Principal Amount" means the**
20 **Appropriated Amount less any withdrawal of funds from the Appropriated**
21 **Amount for expenditure on the Project pursuant to an approved budget or other**
22 **authority granted by the Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
24 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,250.2 FOR; 167.3**
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
