13		(a) All past and future interest and other earnings on the Principal Amount (as						
14		defined below) in the Investment Account shall be retained by the Tohono						
15		O'odham Nation and available to fund governmental operations and projects of						
16		the Nation.						
17		(b) Such accrued interest and other earnings shall be transferred to the General						
18		Fund (Account No. 68-01-101-1067508) on a quarterly basis.						
19		2. For purposes of this Resolution, the term "Principal Amount" means the						
20		Appropriated Amount less any withdrawal of funds from the Appropriated						
21		Amount for expenditure on the Project pursuant to an approved budget or other						
22		authority granted by the Legislative Council.
