5	WHEREAS,	the Appropriated Amount was deposited in a segregated investment account, Account
6		No. 68-01-101-0380535 (the "Investment Account"), and available to pay the
7		designated costs; and
8	WHEREAS,	interest and other earnings in the Investment Account were not dedicated to payment
9		of such costs.
10	NOW, THER	EFORE, BE IT RESOLVED THAT:
11		1. The Tohono O'odham Legislative Council hereby amends Resolution 01-211 as
12		follows:
13		(a) The second resolved clause is repealed.
14		(b) All interest and other earnings on the Principal Amount (as defined below) in
15		the Investment Account for the Nation's fiscal years 2001 through 2004 shall be
16		retained by the Tohono O'odham Nation and available to fund governmental
17		operations and projects of the Nation.
18		(c) Such accrued interest and other earnings shall be transferred to the General
19		Fund (Account No. 68-01-101-1067508) for fiscal years 2001 and 2002 in a lump
20		sum, and thereafter on a quarterly basis.
21		2. For purposes of this Resolution, the term "Principal Amount" means the
22		Appropriated Amount less any withdrawal of funds from the Appropriated
23		Amount for expenditure on the Project pursuant to an approved budget or other
24		authority granted by the Legislative Council.
