1	WHEREAS, the current fiscal year expires on September 30, 2002 upon which the authority of the
2	Tohono O'ODHAM Nation Government to expend appropriated funds shall also cease;
3	and
4	WHEREAS, the leadership of the Nation continue to examine the fiscal requirements of all
1	<u>-</u>
5	governmental operations and capital projects; and
6	WHEREAS, it is in the best interest of the Nation to enact the necessary authority to permit the
7	nations' government (Executive, Legislative and Judicial Branch) funds to continue
8	governmental operations and approved projects beyond September 30, 2002.
9	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
10	authorizes the Tohono O'odham Nation's Government to expend funds to continue all
11	governmental operations and approved projects beyond September 30, 2002.
12	BE IT FURTHER RESOLVED that all employees compensation shall remain at current levels until
13	such time that the Nation's fiscal year 2003 budget is formally adopted which may
14	authorize, retroactive to October 01, 2002.
15	BE IT FINALLY RESOLVED that this continuing authorization re-affirm the authority of the Nations
16	Government (Executive, Legislative, and Judicial Branch) to expend funds
17	appropriated for capital projects.
18	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>13TH.</u> Day
19	of <u>SEPTEMBER</u> , 2002 at a meeting at which a quorum was present with a vote of $\frac{2,068.5}{100}$ FOR;
20	<u>254.85</u> AGAINST; <u>94.15</u> NOT VOTING; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (<u>d</u>) (<u>2</u>) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
