
1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**
2 **Library and Archives, the library agency of the Tohono O'odham Nation.**

3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the**
4 **Venito Garcia Library and Archives' grant proposal for Preservation Assistance Grant**
5 **in the amount of \$2,500.00 from the National Endowment for the Humanities.**

6 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council accepts and authorizes**
7 **the use of the provisions of the grant for the Venito Garcia Library and Archives, and**
8 **waives indirect costs.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
10 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
11 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
12 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
13 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
14 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
15 **Stat. 984).**
