


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing San Lucy District to Continue District Operations Pending Approval
of the District's FY 2003 Budget)**

RESOLUTION NO. 02-412

1 **WHEREAS, Article VI - Section 1 (d) (3) empowers the Tohono O'odham Legislative Council to**
2 **adopt, approve and amend annual budgets and to authorize the expenditure of funds**
3 **in accordance with these budgets; and**
4 **WHEREAS, by Resolution No. SL 09-105-02, the San Lucy District Council is requesting from the**
5 **Tohono O'odham Legislative Council approval to continue governmental operation**
6 **under the terms of its FY 2002 budget ; and**
7 **WHEREAS, currently the San Lucy District Council is in the process of evaluating the needs of the**
8 **district; and**
9 **WHEREAS, the San Lucy District Council desires to have an approved budget prior to October 1,**
10 **2002, thereafter said budget will be submitted to the appropriate Legislative**
11 **Committee for review; and**
12 **WHEREAS, the District has sufficient funds to cover expenditures during this interim period.**
13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the San Lucy District Council's request to continue governmental operations under**
15 **the terms of the FY 2002 Budget, pending approval of the District's FY 2003 Budget.**


16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13th Day**
17 **of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
