

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing Continuation of the San Lucy District Initial Supplemental Set-Aside**  
**Budget from the Nation's Gaming Revenues Savings for FY 2003)**

RESOLUTION NO. 02-413

1 WHEREAS, the San Lucy District Council enacted Resolution No. SL -09-119-01, requesting from  
2 the Tohono O'odham Legislative Council authorization to expend funds in the  
3 amount of \$208,518.55; and

4 WHEREAS, by Resolution No. 01-538, the Tohono O'odham Legislative Council authorized the  
5 District to expend such funds until September 30, 2002; and

6 WHEREAS, on September 5, 2002 the San Lucy District Council met to ascertain status of the  
7 projects from the initiation set-aside budget and found several projects remain to be  
8 completed; and

9 WHEREAS, by Resolution No. SL 09-106-02, the District Council is requesting from the Tohono  
10 O'odham Legislative Council authorization to utilize the unexpended balances  
11 totalling \$157,565.06 until the end of September 30, 2003.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono o'Odham Legislative Council hereby approves  
13 the request from San Lucy District to extend authorization to expend funds in the  
14 amount of \$157,565.06 until September 30, 2003.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day  
16 of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
17 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
18 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
19 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
21 18, 1934 (48 Stat. 984).


