(Adopting the Executive Branch Fiscal Year 2003 Budget and Appropriating
Funds in the Amount of \$35,241,017.43)

RESOLUTION NO. 02-427

1 WHEREAS, the Executive Branch has prepared and presented its Fiscal Year 2003 budget to the
2 Tohono O'odham Legislative Council with the exception of several committee budgets
3 still pending review before the oversight legislative committee; and

4 WHEREAS, the Executive Branch FY 2003 budget funds regular department and program
5 operations; and


6 WHEREAS, the Executive Branch FY 2003 budget is presented in summary as Schedule 1 to the
7 Tohono O'odham Nation Fiscal Year 2003 Budget as well as in detail, which by this
8 reference are incorporated into this resolution.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the attached
10 Executive Branch Fiscal Year 2003 Budget in the amount of \$35,241,017.43, not
11 including those committee budgets still pending review before the oversight
12 legislative committee, is hereby approved.

13 BE IT FURTHER RESOLVED that the Legislative Council does hereby appropriate \$35,241,017.43
14 to fund the Executive Branch FY 2003 budget as presented and attached.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
16 of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,337.15 FOR;
17 80.35 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
18 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
19 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21 18, 1934 (48 Stat. 984).


