RESOLUTION NO. 02-432

1 WHEREAS, the Legislative Branch has prepared and submitted for review and approval their FY
2 2003 Budget; and

3 WHEREAS, the Legislative Council has reviewed the FY 2003 Legislative Branch Budget.

4 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
5 approves the FY 2003 Legislative Branch Budget in the amount of \$2,278,800.00.

6 BE IT FURTHER RESOLVED that the funds in the amount of \$2,278,800.00 are appropriated and
7 authorized to be expended from sources of funding approved by this Council for
8 support of the FY 2003 budgets of the Tohono O'odham Nation.

9 BE IT FINALLY RESOLVED that the FY 2003 Budget is effective October 01, 2002.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
11 of SEPTEMBER, 2002 at a meeting at which a quorum was present with a vote of 1,548.4 FOR; 869.1
12 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
13 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
14 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat. 984).


