

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2003 Budget for the Tohono O'odham Nation Justice
Branch and Appropriating Funds in the Amount of \$4,736,175.00)**

RESOLUTION NO. 02-435

1 WHEREAS, the fiscal year 2002 will end at midnight, September 30, 2002 and all spending
2 authority granted under the 2002 budgets terminate at that time; and

3 WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget to the
4 Legislative Council that reflects the needs of the Branch, a copy of the proposed said
5 budget is attached hereto and incorporated herein by reference; and

6 WHEREAS, the Judicial Committee and the Budget and Finance Committee of the Legislative
7 Council of Tohono O'odham Nation have reviewed this budget and recommends its
8 approval and adoption.

9 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation
10 has reviewed and approved the Fiscal Year 2003 budget submitted by the Judicial
11 Branch.

12 BE IT FURTHER RESOLVED that funds in the amount of \$4,736,175.00 are appropriated and
13 authorized to be expended from sources of funding approved by this Council for
14 support of the Fiscal Year 2003 budget of the Tohono O'odham Judicial Branch.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01st Day
16 of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-
17 AGAINST; 144.5 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
18 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
19 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21 18, 1934 (48 Stat. 984).


