

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2003 Department of Health and Human Services/Indian Health Service Budget)**

RESOLUTION NO. 02-436

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Indian Health Service; and**

3 **WHEREAS, the Legislative Council has approved Resolution No. 02-262 granting the Executive**
4 **authorization to submit the Annual Funding Agreement (AFA) to the Indian Self**
5 **Determination Act Master contract; and**

6 **WHEREAS, the Executive Branch developed approval of the following budgets as attached and**
7 **incorporated by this reference, to be effective October 01, 2002 through September**
8 **30, 2003 and request authorization to expend the funds:**

9 1. **Management of Health Programs - \$482,214.75 + Est IDC \$42,359.42 = \$524,574.17.**

10 2. **Community Counseling & Relations Services Program - \$43,601.72 + Est IDC**
11 **\$6,235.05 = \$49,836.77.**

12 3. **Community Health Division, aka: Community Health Representative &**
13 **Community Health Services - \$1,624,257.86 + \$231,553.87 = \$1,855,811.73.**


14 4. **Behavioral Health Division, aka: Tohono O'odham Psychological Services and**
15 **Alcohol and Substance Abuse Program - \$2,724,061.76 + \$265,130.83 =**
16 **\$2,989,192.59.**

17 5. **Total amount of budgets = \$4,874,136.09 + Est IDC \$545,279.17 = \$5,419,415.26.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is hereby authorized to expend**
19 **funds for the programs listed herein above and as attached in the amounts indicated,**
20 **effective October 01, 2002 through September 30, 2003.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST Day**
22 **of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**
