

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorization to Expend EPA Grant Allocation for FY 2003 of the EPA Fund Account**  
**11-5017 Water Resources Study Program Budget)**

RESOLUTION NO. 02-452

1 WHEREAS, the Water Resources Study Program of the Natural Resources Department was  
2 awarded a continuing Clean Water Act Section 106 grant for water quality planning  
3 and management in the amount of \$150,000.00; and

4 WHEREAS, the Water Resources Study program has proposed a budget in fiscal year 2003 in the  
5 amount of \$150,000.00 to augment its budget line items for salaries, and fringe  
6 benefits; and


7 WHEREAS, this budget has been reviewed by the Water Resources Committee and the Budget and  
8 Finance Committee and is recommended for approval by the Legislative Council.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council acknowledges  
10 that the 5% matching amount of \$7,895 is a requirement for these funds and will be  
11 met through in-kind services provided by the Water Resources Study Program from  
12 the BOR P.L. 93-638 grant, Agreement Number 98-FG-32-00800.

13 BE IT FINALLY RESOLVED that the total budget funding for fiscal year 2003 of \$150,000.00 for the  
14 Water Resources Study Program is approved in accordance with the budget  
15 amendment attached hereto.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> Day  
17 of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
18 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
19 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
20 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
22 Stat. 984).




